MINUTES OF THE JULY 21, 2020
REGULAR CITY COUNCIL MEETING & WORKSHOP
411 TALLOWOOD DRIVE, EL LAGO,
TEXAS 77586

1. **Call to Order** Mayor Findley called the meeting to order at 7:01 PM.

2. **Invocation and/or Pledge of Allegiance** – Pledges were conducted.

3. **Declaration of a Quorum**

Present: Mayor Shawn Findley
Mayor Pro Tem Ann Vernon
Councilperson Charles Parette
Councilperson Darin Clark
Councilperson Kris Kuehnel
Absent: Councilperson Jeff Michalak

4. **Citizen Comments**

Jeff Tave of 302 Pineview Circle requested that more time be put into planning for the expenditure of PEG funds and to check with other cities the size of El Lago to see what those cities are doing with these funds. He stated he did not think that visual streaming of meetings was necessary, and that audio was enough. He also requested that these funds be used to send out informational videos to the community.

Art Richard of 622 Bayview Drive asked about hurricane preparedness plans, and he also inquired about street cleaning and debris removal contracts in the event a hurricane. Councilperson Clark stated he and the Emergency Management Coordinator were looking into these contracts. He also stated hurricane preparedness information was communicated on the website in May, but he would look into reposting the information.

Tiffany Wallace of 711 Crestwood Drive asked when the blue street reflectors which mark the fire hydrants would be installed. She also requested that a speed limit sign be placed on Crestwood before school begins. She said many homes in El Lago did not have numbers painted on curbs in front of their homes marking the address, which makes it difficult for emergency vehicles to find them. Finally, she informed Council that the construction at Ed White Elementary was causing mud and rocks in the streets along with standing water. She asked how long this construction would continue. Mayor Findley informed her that the blue reflectors and the speed limit sign installation are in motion. He said he would address the residents about the addresses being painted on curbs or displayed on homes. Chief Nunn stated he already addressed the company handling the construction at Ed White Elementary about cleaning up the site on an ongoing basis and he was told the job there was scheduled to be completed by the time school begins.

5. **Consent Agenda**

5.1. *Check Detail for checks printed from July 8, 2021 through July 21, 2021.*

5.2. *Minutes from the Council Meeting July 7, 2021.*

Councilperson Parette made a motion to approve the consent agenda and a second was provided by Councilperson Clark. The vote was unanimous to approve.

6. **Special Recognitions**

6.1. *Recognize City of El Lago Lifeguard, Audra Klinger, for her actions to save the life of a City Pool patron.* Mayor Findley recognized Audra Klinger for her actions on June 12, 2021, stating that her quick actions saved the life of a pool patron who was suffering from heat exhaustion. She was given a Certificate of Appreciation from the Mayor.

7. City Official, Board, Commission, Committee, & City Service Report

- 7.1. *Report on SVFD call and response time reports for June, 2021.* Andy Gutacker covered both May and June calls since he was unable to attend the last meeting. He reported in May there were a total of 8 calls, 3 were medical, 3 were weather causing a power line, the others were fire. He stated the average response time was 10 minutes which was not normal, but it was due to the activity surrounding the power line. In June there were 11 calls, 6 were medical, and 5 were fire responses and HAZ-MAT and gas line calls. He encouraged all citizens to be sure they have house numbers on their homes for emergency responses. Chief Gutacker informed Council that he and 10 members of his Department attended two days of rescue swimming class.
- 7.2. *Report on LPD activity in the City with Call for Service reports for June, 2021.* Chief Nunn presented his Call for Service reports for June, 2021. He stated that his Code Officer could help to address the missing addresses on homes. He reported that call volume was down but that parking tickets were up. He reported the PD is currently understaffed but the other officers have been volunteering to help with coverage. Mayor Pro Tem Vernon suggested that the city first send out informational messages regarding the addresses before the Code Officer becomes involved. Chief Nunn also said he planned to look into borrowing a mobile speed limit sign from a neighboring city to use for 30 days at different locations throughout El Lago.
- 7.3. *Present the 3rd Quarter Financial Report for FY 2021.* Cheryl Hunter presented the 3rd Quarter Financial report. She went over the Balance Sheet which reflected total assets of \$1,506,899, total liabilities of \$117,221, and a total fund balance of \$1,389,668. She then reviewed the revenues and expenditures. Total revenues were \$1,960,405 which was 91.9% of the budget. Total expenditures was \$1,424,439 which was 64.5% of the budget. The excess of revenues over expenditures was \$535,966.

8. New Business

- 8.1. *Consider/Approve the FY 2021 3rd Quarter Investment Report.* City Secretary, Rachel Lewis, went over the 3rd Quarter Investment Report in the absence of Councilperson Michalak. There was no interest earned during the quarter. Mayor Pro Tem Vernon made a motion to approve the report and Councilperson Kuehnel seconded. Approval was unanimous.

9. Adjourn into an Executive Session as allowed by Texas Local Government Code §551.074 to discuss Legal and Personnel Matters.

Mayor Findley adjourned into Executive session at 7:48 PM
